**Arizona Cowboy Mounted Shooters Association, General Release of Liability
for Cowboy Mounted Shooting and Related Activities**

Since the use of firearms and/or horses can be dangerous, all shooters and people entering the area assume all risk by signing this release. I hereby acknowledge that I have voluntarily applied to participate in the sport of "Cowboy Mounted Shooting" and/or related activities including, but not limited to equestrian events such as the monthly shoots and trail rides and other club activities and entertainments. As lawful consideration of being permitted to enter upon the premises upon which this event is conducted and of being permitted to participate in these activities or otherwise use the facilities, I, the undersigned, for my heirs, distributees, legal representatives, next of kin and assigns agree to the provisions set forth below:

1.) I hereby release, waive, discharge and covenant not to sue, make a claim against the property of or other to prosecute the Arizona Cowboy Mounted Shooters Association and owners of the facility used for competitions or activities, its officers, directors, shareholders, members, agents, and/or employees, (for all purposes collectively referred to herein as "RELEASEES") for liability on account of damage to the property of or injury to the person or death of the undersigned, whether caused from the passive or active negligence of RELEASEES or otherwise while the undersigned is participating in or observing the sporting or related activities of this club.

2.) The UNDERSIGNED expressly agrees that this release, waiver and indemnity agreement is intended to be broad and inclusive as is permitted by the laws of the State. The undersigned further agrees that if any provision of this agreement is held to be invalid, nevertheless, the balance of the agreement shall contain in full legal force and effect.

3.) The UNDERSIGNED warrants that the following statements are true and correct and understands that RELEASEES have relied on them in accepting this release, waiver and indemnity agreement and in giving the UNDERSIGNED permission to participate in and/or observe the sporting and other activities being conducted by RELEASEES. A.) The UNDERSIGNED is aware that the participation in or the observation of the sport Cowboy Mounted Shooting with loaded firearms, equestrian handling for the events and related activities is a hazardous activity. The UNDERSIGNED does voluntarily participate in or observe these activities with the knowledge and appreciation of the danger involved, the UNDERSIGNED agrees to accept any and all risk of property damage, personal injury, or death. B.) The UNDERSIGNED gives consent to whatever medical care might be provided or available on the premises and further agrees to conform and comply with all of the rules and regulations applicable to the event. C.) The UNDERSIGNED agrees to compensate or reimburse RELEASEES for any costs, expenses or damages, including attorney fees, resulting from any claim brought against RELEASEES for property damage, personal injury or death which arise as a result of the passive or active negligence or other acts of the UNDERSIGNED while participating in or observing the shooting and/or equestrian events and related activities conducted by the RELEASEES.

D.) The UNDERSIGNED has carefully read and fully understand the covenant not to sue contained herein, and voluntarily signs this release, waiver of liability and indemnity agreement. E.) If the UNDERSIGNED is under the age of 18 a parent signature is also required. F.) The UNDERSIGNED understands that one signature is valid for the calendar year of association activities.

2015 CMSA Release

(Required for CMSA membership only)

I understand that I am participating in a sport, which contains dangers, and risks may arise, including, but not limited to, accidental injury, the forces of nature and illness. In consideration of the right to participate in these events and the services provided for me by the Cowboy Mounted Shooting Association and its agents, I have and do hereby assume the risks associated with such events. The contestant shall at his own expense, defend management and/or all sponsors, their cardholders, or employees from any and all such claims and indemnify, from any and all liability, damage and costs arising from injuries to person or property occasioned by any act or omission of the contestant. Membership in the CMSA is a privilege and requires that those who compete in events meet all local, state and federal requirements to legally possess firearms for the purpose of such competition. Therefore it is the responsibility of all members to insure that they are legally able within the state or country that they are competing in to own and/or possess firearms. If the CMSA is notified by proper authorities of a member's inability to legally possess the firearms required to compete in CMSA sanctioned events that membership will immediately be suspended. By joining CMSA, I am agreeing that images of my horse, equipment and myself may be photographed, videoed or recorded in any way and re-used without my permission and without compensation. I further agree to support and enforce CMSA Rules as stated in the CMSA Rule Book. This Solidarity Agreement binds all CMSA Members to enforce CMSA Rules and assure our competition cardholders they will play the same game worldwide when they travel for CMSA competitions.
